Our health services include free or low cost HIV/AIDS medical care, individual and group counseling, HIV/STD testing and prevention, and alternative insemination. The Center also offers legal, social, cultural, and educational services, with unique programs for seniors, families, and youth, including a 24-bed transitional living program for homeless youth.

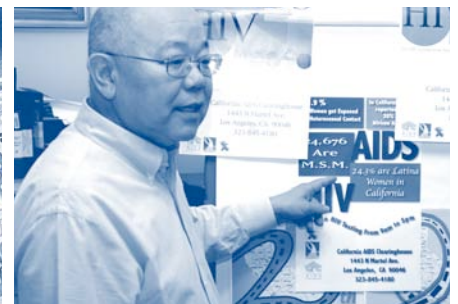

Letter from the Board of Directors



Dear Friends:

No single role adequately describes the relationship between the L.A. Gay & Lesbian Center's staff/volunteers and the tens of thousands of people who benefited from the organization's wide variety of services this year. Physician. Big Brother/Sister. Therapist. Pharmacist. Educator. Attorney. Advocate. Collaborator. Nutritionist. Activist. Friend. We are all those and more to the gay, lesbian, bisexual and transgender community in Los Angeles.

The staff of the Center's homeless youth residential program are considered surrogate parents (or big brothers/sisters) by the 28 formerly homeless GLBT youth who lived there this year and found not only a safe and caring place to live, but the tools, resources and support to make it on their own. More than 300 other GLBT youth, living on the streets of Los Angeles, received breakfast and lunch, counseling, job skills, HIV testing and more at our Jeff Griffith Youth Center this year.

We are board-certified physicians and nurses who provided expert free or low-cost HIV and other STD medical care to 1,800 people at our Jeffrey Goodman Special Care Clinic this year, and we are counselors to the more than 10,000 people who got a free rapid HIV test. We're pharmacists who distributed more than \$19 million worth of life-prolonging medications, mostly to those who otherwise couldn't afford them, and we're a nutritionist to the hundreds of HIV-positive patients who learned how to maintain a healthy weight and adhere to their drug regimen.

As therapists we provided 18,208 hours of free or low-cost counseling to help more than 1,500 people battle addiction to crystal meth and other drugs, combat depression and domestic violence, and deal with relationship challenges, anger management and a variety of other issues.

We are friends/lifelines to the many GLBT people in our seniors program who count on us for enriching programs and activities and to the more than 400 families who turn to us for support, advice and events/activities specifically for GLBT parents and their children.

To the thousands who are impacted by one of our HIV-prevention campaigns, or the hundreds who turn to us for help to stop smoking or to learn professional development skills like computer training and writing, we are educators. To the more than 40 community groups who get free or low-cost office, event and meeting space at The Village at Ed Gould Plaza, or who partner with us on a wide variety of initiatives, we are collaborators.

We're attorneys offering free or low-cost legal advice to the 2,431 people who sought help for everything from landlord/tenant disputes to domestic partnership agreements through our legal clinic. And for victims of domestic violence and gay bashings, we are forceful advocates.

To (and for) the entire GLBT community, we are activists fighting for marriage equality, full civil rights and social justice. This year our Vote for Equality program educated and identified 15,000 voters who support marriage equality for gay and lesbian couples and who can be mobilized to vote against any measure that would amend the California constitution to prohibit same-sex marriage.

We are all of these things for the community we serve because of who you are... the lifeblood that enables us to meet the growing demand for our services and programs. On behalf of the entire Board of Directors, we thank you for your support of the L.A. Gay & Lesbian Center and our work.

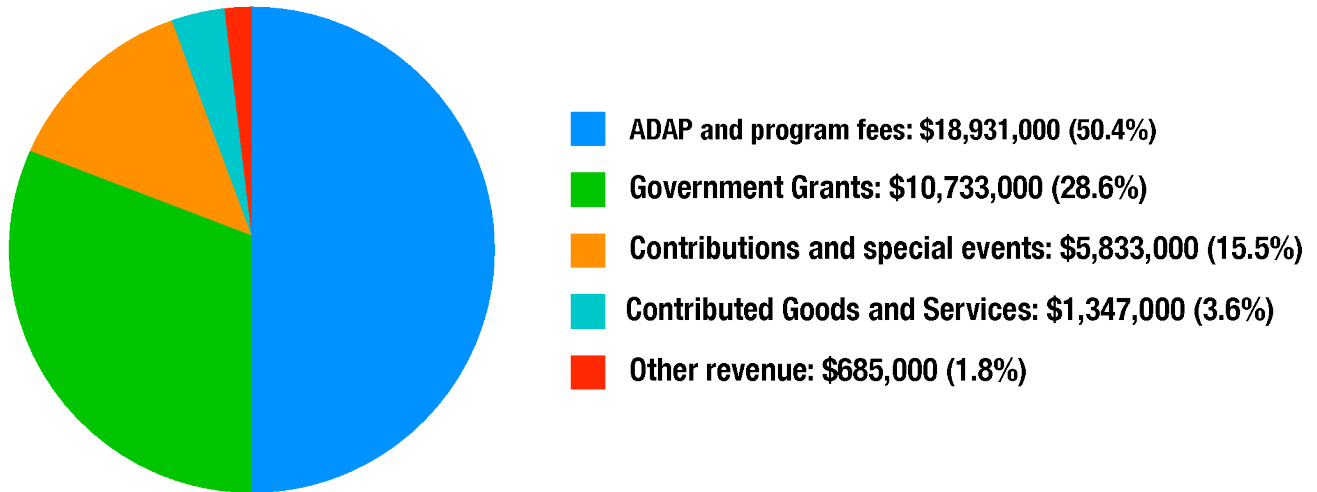

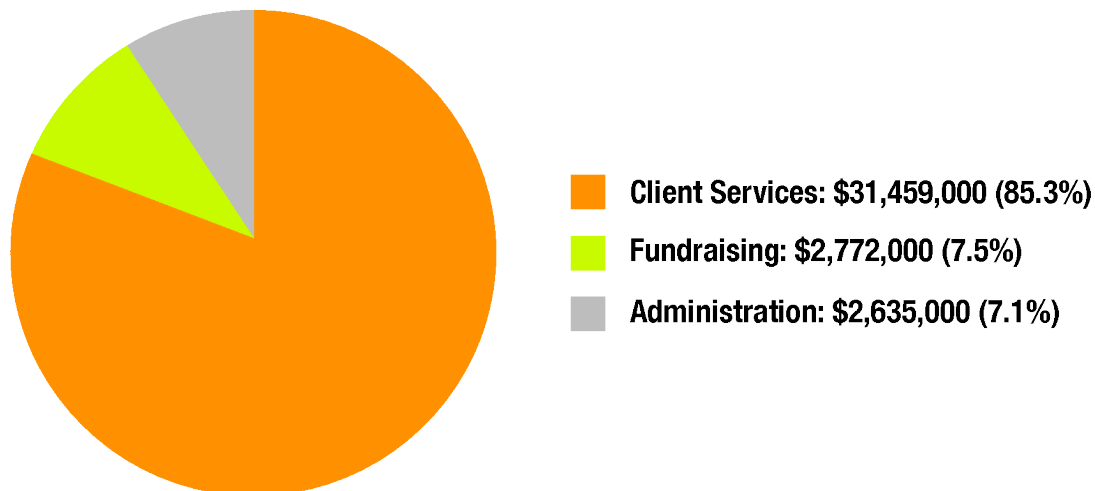


Financial Statement
